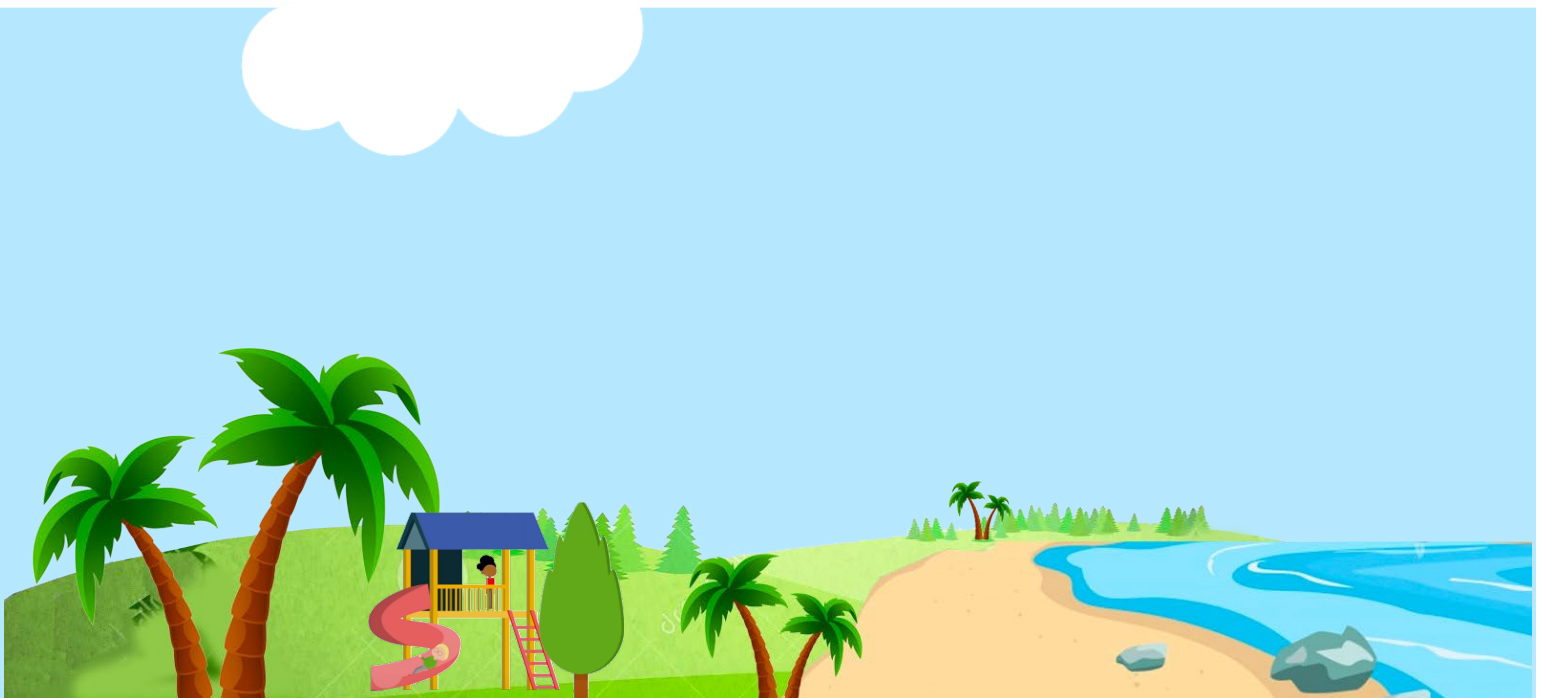

A LEGACY OF COMMUNITY AND COMMERCE

A ship comes to Port, tug and pilot operators bring her in, a skilled local ILWU crane operator offloads the cargo, Customs workers make sure the cargo is secure, and a trucker picks it up. All of these workers enjoy breakfast and lunch at local establishments and then head to local stores for supplies. The cargo then goes to retail, where Joe and Mary just got jobs to provide for their families. Their kids go to a school whose teachers prepare them for the future, and law enforcement keeps them safe.



Since its inception in 1937, the Port of Hueneme has embraced a legacy of trade and community enrichment. Throughout this history, the Port and its customers directly or indirectly have provided thousands of jobs to community residents, supported many local business enterprises, and participated in a diversity of community events and activities. In addition to the positive economic impacts, Port customers pay their share for doing business here. The Port does not receive funding from taxpayers for operations, but rather runs off payments from its customers. Approximately 10% of this revenue is in turn provided to the City of Port Hueneme through negotiated agreements. These funds, totaling over \$2.6 million in fiscal year 2023, support City infrastructure and public services, and also mitigate the impacts of Port operations.

THE FORMATION OF THE COMMUNITY BENEFIT FUND

IT'S ALL ABOUT COLLABORATION AND PARTNERSHIP FOR PUBLIC BENEFIT

Through the course of time there are moments when questions are asked, and debates ensue. This was the case in 2013 when the City brought forth a legal challenge contending that Port's revenue sharing payments to the City were miscalculated. After 2 years of litigation, the City and the Port came to common ground and opted to settle the dispute on friendly terms outside the courts. A resulting settlement agreement in 2015 created a win-win for both parties.

The first collective win was a land transaction. For a payment of \$1.1 million, a 2-acre property lease to the City was dissolved 18 years in advance of its termination date, making that land available for Port use and new commerce opportunities. At the time, the City was faced with financial hardship and the \$1.1 million installment helped address budget shortfalls.

The other mutual win that evolved out of this landmark settlement included the creation of a Community Benefit Fund (CBF). The City and Port established this fund to re-energize their tradition of partnership and collectively agreed that working on projects together would foster unity and collaboration with the most impactful and meaningful results for the community. In this spirit of partnership, the City Council and the Board of Harbor Commissioners agreed to meet regularly and develop projects for the betterment of the community using allocations from the CBF. The agreement spells out that in years when the Port generates over \$13M in revenue, it allocates \$100,000 to a restricted CBF account for the purpose of investing in community projects and initiatives that are mutually agreed upon by the City and Port. To date, \$1,005,247 has been allocated by the Port to the CBF for this altruistic cause.

THE PROCESS FOR TO INVEST IN MUTUALLY BENEFICIAL PROJECTS

The settlement agreement of 2015 established a process to ensure the spirit of partnership and collaboration among the Board of Harbor Commissioners and City Council members was upheld. The agreement requires that the City and Port each appoint three representatives (two members of the elected Harbor Commissioner Board and City Council and one member of the staff for each party), who will meet within 180 days following the start of any new fiscal year in those years that there is a positive balance of money deposited in the CBF. The Port and City representatives are tasked with mutually deciding on whether to spend any of the CBF on a project(s) that year, and if so, which project or projects will be selected for the expenditures. The decisions of the representatives will then be subject to approval of both the full Board of Harbor Commissioners and the entire City Council. If the representatives are unable to agree on expenditures for the CBF in a given year, the agreement calls on the City Council and Board of Harbor Commissioners to convene a joint meeting to discuss proposed projects in an open session with members of the public. If the City and Port do not agree after 3 years, each party receives 50% of the funds to spend at their individual discretion.

ELIGIBLE COMMUNITY BENEFIT FUND PROJECTS

The agreement requires projects to fall within the following broad categories of public benefit:

- ▶ **Shoreline Protection:** Monitoring beach profiles, scrutinizing biannual sand replenishment operations and constructing associated improvements to protect the NCEL (owned by the District) and Hueneme Beach Park (owned by the City).
- ▶ **Community Development:** Implementing joint initiatives that foster the community's economic, social and environmental well-being including, but not limited to, public infrastructure improvements, sponsorship of special events, support of civic organizations, and similar activities.
- ▶ **Opportunistic Endeavors:** Pursuing opportunities that foster the shared mission and interest of the City and District not otherwise described above including, but not limited to, economic development grants, environmental mitigation, enterprise zone establishment, joint trade missions and similar activities.
- ▶ **Other Projects:** Any project or projects as may be agreed to in any year by the District's Board of Harbor Commissioners and the City Council, except for fiscal years 2014/15 and 2015/16 where the City as granted sole discretion can make such determination.



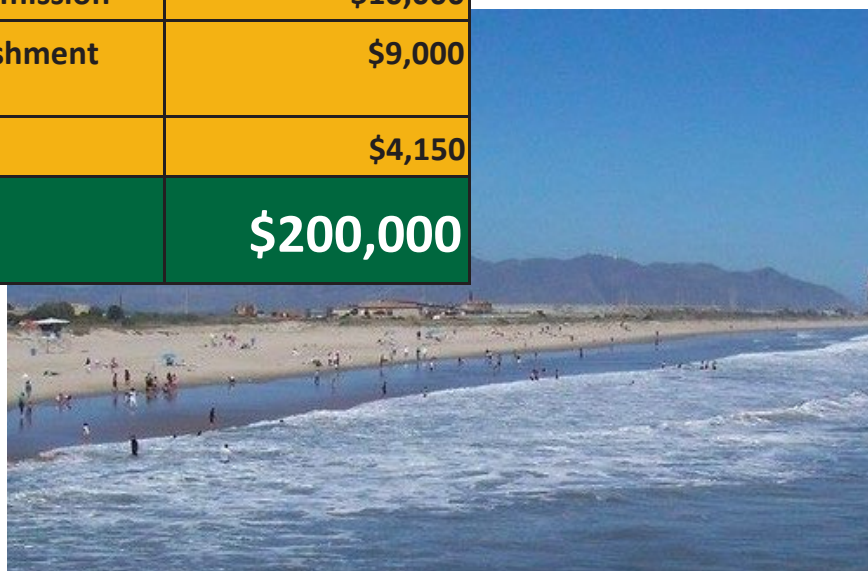

The first two years (FY 2015 & 2016) projects were at the discretion of the City as long as it benefits the community. The monies were used on the following projects:

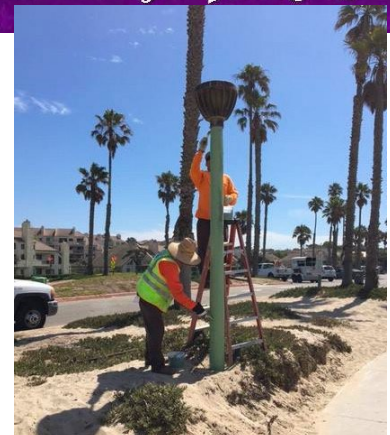
